Financial Audit 2022-2023

The financial audit for the year 2022-2023, identify that the accumulated surplus in School generated funds is \$98,000. These funds do not belong to CSCE and do not appear in the accumulated surplus. The audit also show net income of \$18,497,103 and total expenses of \$18,188,498 for a surplus for the year of \$308,605, bringing the CSCE's accumulated surplus to \$844,000. This surplus represents approximately 4.56% of the CSCE's operating budgets and is below the threshold for an allowable surplus, according to the Funding Manual published by Alberta Education.

The trustees also requested that the auditor come in for a mid-year audit to work with the executive team on budget forecasts for 2023-2024.

JUPA Agreements
